The Mariposa Grizzly Band Boosters have selected Music Celebrations International as the service provider for our trip to Washington, DC. They will coordinate transportation, lodging, meals and sightseeing for us and have provided more information about their services and itinerary is the attached packet. Please note that while the travel dates are firm, the daily schedule is subject to change.

The cost for the trip is estimated to be \$1600 per student. The Grizzly Band Boosters are committed to providing \$800/per student to help defray the cost of the trip. To be eligible for this contribution, students must participate in all practices, events, and fundraising activities or have the absence approved by Mr. Fiester.

Please select one of the following payment plans. These plan dates have been chosen to reflect dates when the Boosters are required to make trip payments, so it is important that each of us makes timely payments. FULL PAYMENT MUST BE RECEIVED BY April 1, 2015 in order to travel to Washington, DC.

_____ Plan A: Deposit of \$150, due October 10, 2014
2 payments of \$325, due January 15 and April 1, 2015

_____ Plan B: Deposit of \$150, due October 10, 2014
4 payments of \$162.50, due Nov. 15 2014, and Jan.15, Feb. 15 and April 1, 2015

_____ Plan C: Deposit of \$150, due October 10, 2014
Monthly payments of \$108.50 due Nov.1 2014 through April 1, 2015

Because the trip is being offered by a 3rd party provider, deposits are non-refundable. Partial refunds for trip cancellations will only be available until December 15, 2014. Additional travel insurance, that includes coverage for trip cancellation, is available for purchase through Music Celebrations International (see attached Travel Protection Plan form). Students who have not paid in full by April 1, 2015 will not be eligible to travel to Washington, DC and will not be eligible for a refund of partial payments.
